

# PERRY ELLIS WARDROBE GIVEAWAY

## PENNSYLVANIA

### OFFICIAL RULES

**NO PURCHASE OR PAYMENT IS NECESSARY TO ENTER OR WIN.** A purchase or payment will not improve your chances of winning. The Perry Ellis Wardrobe Giveaway – Pennsylvania (the "Giveaway") begins at 12:00:01 a.m. Eastern Standard Time ("EST") on December 11, 2019 and ends at 11:59:59 p.m. EST on December 24, 2019 (the "Giveaway Period"), when all entries must be received. EST shall control for all purposes of this Giveaway. Sponsor's computer is the official time-keeping device for the Giveaway. The Giveaway is governed by these Official Rules and is subject to all applicable U.S. federal, state and local laws. Void where prohibited.

**1. Eligibility.** The Giveaway is open only to legal residents of Pennsylvania, who are 18 years of age or older at the time of entry. Proof of residency and age may be required. Employees of Perry Ellis International, Inc. and its respective subsidiaries, divisions, affiliates, and advertising or promotional agencies, and the immediate family and household members of such individuals, are not eligible to enter or win.
